INTRODUCTION

This directory lists all the Probation Residential Service (PRS) agencies that are under contract with the Michigan Department of Corrections (MDOC), for the provision of services to qualifying offenders under MDOC jurisdiction and felony pretrial status.

Effective October 01, 2015, **ALL** counties have access to Probation Residential Services, regardless of an established CCAB within the area.

Probation Residential Services (PRS) eligibility criteria is as follows:

- Pretrial offenders, regardless of adjudication status, or sentenced felony offenders scoring moderate to high in at least one of the following: 1) Overall COMPAS risk potential, Residential Instability, GED/Vocational, Substance Abuse, Cognitive Behavioral and/or other categories that would match risk/need with programming at the referred PRS site.
- Felony offenders convicted of MCL 257.625 – 3rd Offense - *Operating a motor vehicle under the influence of intoxicating liquor or a controlled substance, or both, 3rd or subsequent offense, under section 625(9)(c) of the Michigan Vehicle Code, 1949 PA 300* – Offenders must also score moderate to high in at least one of the following: 1) Overall risk

potential, when using a State approved actuarial risk/need assessment; -OR- 2) Substance abuse need, when using a State approved actuarial risk/need assessment.

- Parole violators are eligible pursuant to policies and procedures which identify and prescribe local correctional interventions to be utilized as alternatives to a prison return. Eligibility is limited to Level III Parole Violators and those departed upward to Level III, which require Parole Violation Specialist review as defined within the MDOC's Parole Violation Response Guidelines

Probation or parole violators that are low risk may be referred to PRS with Regional Manager, Probation Sentencing Specialist, or Parole Violation Specialist approval.

TO ACCESS

All MDOC Agents or Parole Violation Specialist may contact the selected Probation Residential Services (PRS) facility directly to initiate a referral.

When contacting the selected Probation Residential Services (PRS) facility, MDOC Agents and Specialist should identify the referral as one from the Department of Corrections and indicate that a Probation Residential Services (PRS) placement is desired. The referring Agents are responsible for the completion and submission of appropriate referral and eligibility paperwork to the receiving facility. Referral and eligibility paperwork include, but may not be limited to:

1. CFJ-140
2. Basic Information Report
3. Probation Order
4. COMPAS Assessment Scores (sentenced offenders)
5. PRAXIS scores and/or Court Order with bond conditions (pretrial offenders)

Should the agent have any difficulty with a contracted facility listed in this directory, the agent may contact the Michigan Office of Community Corrections' Probation Residential Services Analyst. Michigan Office of Community Corrections staff contact information is listed on page 2 of this manual.

Addiction Treatment Services (ATS)

SERVICES

ATS offers each client a 90-minute biopsychosocial assessment by a master level licensed therapist. Upon completion, recommendations are made for group placement among these choices: Moral Reconciliation Therapy (MRT), Anger Management (CBT), Relapse Prevention Group (CBT), Seeking Safety (CBT Group addressing Post Traumatic Stress Disorder/Substance Use Disorder)

MEDICAL RESTRICTIONS

Controlled Substance (these prescriptions are not allowed), must be medically stable (accept managed chronic, but no acute conditions), Psych Stable (if on medication must be stabilized)

OTHER RESTRICTIONS

CSC 1st Degree (case by case basis), client must be ambulatory, needs base line literacy, no females (males only facility).

FACILITY OVERVIEW

Twelve bed facility (single bed sleeping area) for males located in downtown Traverse City. Within easy access to employment, treatment, and services. Case management provided for addressing all life domains. Agency also has Recovery Housing and Outpatient Services for next level of care.

FACILITY OVERVIEW

Alternative Directions is a 43,000 square foot facility that provides residential services for up to 115 men on the second and third floor of the building. Residents share a room with either one or two others. Bedrooms have a sink and mirror area, with a toilet between two rooms. There are six shared bathroom/shower rooms between both floors. There is a TV room on each floor and a recreation room in the basement that is utilized in the evenings and on weekends. There is separate meeting space for classes and individual appointments. There are also private computers and phones available to residents to have virtual counseling, if needed. The building is centrally located in Grand Rapids, with a bus stop just outside.

Kalamazoo Probation Enhancement Program (KPEP) **Males & Females**

SERVICES

Programming requirements are based on an objective assessment and/or court orders in collaboration with the referral source, lengths of stay are between 90 and 150 days.

PRS Outpatient includes cognitive behavioral therapy, outpatient sex offender and/or substance abuse treatment, 60 hours of community service, 60 hours of structured activity weekly including therapeutic activities, employment, etc. 15 staff led hours/week, employment eligible if approved.

PRS Regular includes cognitive behavioral therapy, substance abuse didactic sessions, 60 hours of community service, 60 hours of structured activity weekly including therapeutic activities, employment, etc. 15 staff led hours/week, employment eligible if approved.

PRS Vocational includes cognitive behavioral therapy, substance abuse didactic sessions, 60 hours of community service, 60 hours of structured activity weekly including therapeutic activities, employment, etc, 30 staff led hours/week Hospitality Services or Building Trades training, employment.

FACILITY OVERVIEW

KPEP Calhoun (203 Brigden Drive Battle Creek, MI 49014) is 10,700 square foot facility housing male residents. The facility can house up to 63 residents with 2-3 per room.

Case management, and stabilization. OGD utilizes a CBT curriculum in programming and utilize Certified Peer Support Specialist. OGD coordinates with physical and mental health partners to ensure optimal outcomes with the clients served. *OGD provides housing placement assistance and can accommodate registered sex offenders.*

MEDICAL RESTRICTIONS

Case by Case basis.

OTHER RESTRICTIONS

Include clients that are not ambulatory, Women (Male only facility)

FACILITY OVERVIEW

Operation Get Down (OGD) is currently setup to accommodate ten (10) adult male residents. Rooms are designed in a barrack style, allowing at least 50 square feet of living space per resident. Rooms include one (1) twin size bed, one (1) dresser with at least three (3) drawers, one (1) locker and one (1) designated wall electrical outlet (to accommodate tether, cell phone etc..). OGD is a secure location with 24/7 security monitor presence. OGD utilizes up to date COVID-19 avoidance protocols and coordinates daily with the Detroit Health Department for temperature checks and regular COVID-19 testing.

SERVICES

Heartline provides 24-hour staff supervision, camera monitoring with audible door alarms. Each resident is provided individual intensive case management which includes: an individualized service plan, medical history questionnaire, biopsychosocial and life skills assessment. Carefully selected courses are instructed by qualified lecturers in: The Courage to Change Cognitive Behavioral Therapy (CBT), Moral Reconciliation Therapy (MRT), substance abuse therapy, relapse prevention, employment skills, self-esteem, GED prep class, guest speakers, the Money Smart curriculum provided by local bankers and the Wayne County Community Reinvestment Act, Michigan State University's parenting, anger management and stress less curriculum. Weekly Narcotic Anonymous (NA) and Alcoholic Anonymous (AA) meetings are held onsite. Medical students from Authority Health present an educational bi-weekly lecture regarding medical issues. Transportation is provided to the residents by either staff, taxi or bus cards paid by Samaritas. Interpreter and translator services are on call 24 hours a day for over 150 different languages. Ascension Health provides Open Arms for weekly trauma support and grief & loss recovery. Yoga instructors provide meditation and relaxation.

Self Help Addiction Recovery (SHAR) **Males & Females**

SERVICES

SHAR provides residential SUD treatment in gender specific programs to male and female PRS clients. The program is trauma informed and client centered. Clients are treated holistically, and through case management, SHAR can address physical and mental health needs. Groups are on a wide range of topics, from coping skills, relapse prevention planning, communication, and healthy relationships. Individual sessions are client focused and can include the family/social supports, at the request of the client. Clients can request and work with Peer Recovery Coaches while the program, and 12 step recovery principles are part of the SHAR program. The goal is providing a solid foundation for recovery that addresses the physical, emotional, mental, and social needs of our clients.

MEDICAL RESTRICTIONS

Clients with a recent history of seizures or those not stable on a medication for seizure disorder are not eligible for admission. SHAR not able to accept clients who currently are in chemotherapy, have renal or congestive heart failure, or are on blood thinners. Clients must be able to attend to their own activities of daily living (hygiene, etc.).

OTHER RESTRICTIONS

SHAR-Macomb is not able to admit any clients convicted of CSC or Arson.

FACILITY OVERVIEW

SHAR-Macomb is a 70,000 square foot facility set on 7.5 acres of land. Men's and Women's Units are gender specific and separate. Clients are housed with no more than 3 residents to a room, per recommendations of physical distancing. Each room has a suite style bathroom, with showers located on the units. SHAR-Macomb has a large courtyard, with a running track, softball field and horseshoe pit in the recreation yard

**SHAR-Macomb provides transportation from Wayne, Oakland, and Macomb County Jails. SHAR also escorts all clients who have necessary appointments outside of the facility, provided that those appointments are urgent in nature and cannot wait until treatment is completed.*

SERVICES

Punitive Service: Standard/Intensive Program, *Domestic Violence Program (Duluth Model)*, Residential Work Placement, Pre-Trial services, on site Drug/Alcohol screening/testing. Classes include job readiness; GED prep classes and testing; Cognitive restructuring focused groups; anger management' life skills; parenting, nutrition, community-based support groups, case management, medical services and 24-hour supervision. Poly-Com and Zoom are available for the courts, agents, and attorneys

Substance Abuse Services: *Opiate Specific Program (This program is available to Saginaw, Bay, Midland, Tuscola, Lapeer, Jackson, and Ingham Counties)*. Offering a higher dose of substance abuse treatment with 30, 60, 90, and up to 150 days in a residential setting. Determination for programming requirements is based on an objective assessment, court orders in collaboration with the referral source. Services focus on the treatment of substance use disorders with or without co-occurring mental health disorders within various treatment modalities: Cognitive Behavioral Therapy, Motivational Interviewing and Trauma-informed Care to name a few. Each resident receives a minimum 15 hours a week of group classes with individual weekly therapy sessions. Therapeutic groups and individual sessions are provided by master level therapist as described by Licensing and Regulatory Affairs. Groups are evidence based practice with curriculum that includes but no limited to: Thinking Matters; Thinking for a Change; Anger management (CBT), Relapse Prevention (CBT), Early Recovery Skills (CBT) Helping Men/Women Recover, TREM; M-TREM, Seeking safety; Co-Dependency, Living In Balance, 12 Step Meetings (NA/AA) RU, Case Management services, Medical Services, Vivitrol Injections, Peer Recovery, Life Skills and Healthy Living. 24-hour supervision.

Probation Residential Services (PRS) Provider Requirements

1. Documented Case Management Plan.
2. Monitor offender participation in program and update Probation/Parole monthly.
3. Appropriate referrals for additional programming or services including medical treatment, or other social or rehabilitative services, substance abuse treatment, mental health treatment, high school completion and other education services, job training, job seeking, job placement services, personal financial management.
4. Access to transportation for necessary medical/treatment appointments, employment, or other identified rehabilitative needs.
5. Access to recreational activities.
6. Structural schedule of daily activities to offender.
7. Budgeting or financial management counseling to offender.
8. Random drug testing to offenders or as agreed upon by Probation Agent or Court Order.
9. Educational programming, or access to education programming such as GED or High School completion.
10. Employment-related services
11. Medical assessment and treatment and provide appropriate medical care when needed.
12. Community service work placement and supervision.
13. After-care services.
14. At least one cognitive-based group shall be provided. The curriculum must be approved by the Office of Community Corrections and the facilitator must maintain appropriate licensure and/or appropriate training certification. Documentation of group attendance and participation must be maintained in the case management plan.

15. Two group sessions per week shall be delivered. Each group to last between 1.5 to 2 hours.

The following standards apply for agencies providing substance abuse services

1. A detailed treatment plan for each eligible offender shall be completed within ten working days after admission. The plan shall be based upon information obtained during the assessment and intake process.
2. The treatment plan shall include a diagnosis of substance abuse dependency, treatment goals, and the frequency and types of treatment services and supportive social services to be provided. Documentation must be maintained in the case management plan.
3. The treatment and rehabilitation regimen will include weekly scheduled therapeutic activities for each offender. The scheduled activities shall consist of group counseling, education, social work and planned recreational activities.
4. Two psycho-education group processing sessions each week. Each group to last between 1.5 to 2 hours. Six hours of staff led or supervised therapeutic activity. Examples may include AA meetings, NA meetings, SA meetings, Mindfulness exercises, etc.
