## HOW CAN I CHANGE MY CHILD SUPPORT ORDER?

You are eligible for an income review every three years, or if there has been a significant change in your financial circumstances, such as a job loss or significant change in income. **Your Options:**

- Submit a [written request](#) to FOC for an income review. If you have asked for a review in the past three years, be sure to provide proof of your significant change in circumstances.
- File a Motion to Change Child Support at the Circuit Court. Forms and instructions are available in our lobby or at: [www.accesskent.com/foc](http://www.accesskent.com/foc).
