Letters will not be renewed until all annual filing requirements have been completed by the guardian(s) and standby guardian(s): filing of the Annual Report in all guardianships and filing of Proof of Service of the Annual Report on all Interested Persons in developmentally disabled and adult guardianships. There is no charge to renew Letters, however, there is a \$12.00 charge for a certified copy.

AS REQUIRED BY MICHIGAN COURT RULES YOU ARE NOTIFIED:

You are required to file with this court a written report on the indicated form(s) and at the indicated times. Forms are available at the Probate Court or you may find them on line at <a href="www.accesskent.com">www.accesskent.com</a>. Select the Courts/Law Enforcement tab; select Probate Court. On the left column select Court forms. The annual report can be found under the Annual Guardianship Reports section.

<u>CHANGE OF ADDRESS or PHONE:</u> You are required to promptly inform the court of any change in the ward's address and/or telephone number within 14 days of the change. You are also required to keep the court and interested persons informed in writing within 7 days of any change in your address.
