PUBLIC SAFETY

- SINCE APRIL 2022
 - 20 HOMICIDE TRIALS- 17 GUILTY, 2 NOT GUILTY, 13 TRIALS IN 2023 ALONE
 - ISSUED CHARGES ON 23 MORE
 - 18 UNDER INVESTIGATIVE SUBPONEA
- CARRY CONCEALED WEAPON
 - 676 CHARGES
- R/C MOTOR VEHICLE
 - 666 CHARGES
- UNLAWFUL USE/DRIVING AWAY OF AUTO
 - 326 CHARGES

FAMILY LAW- 2022

- Service of Process-successfully performed on non-custodial parent, or three documented attempts prior to federal expiration date
 - **Kent 75.8%**, Genesee 77.9, Macomb 54.4; Wayne 36.1
 - This is a 22% increase for Kent, made by various best practice improvement and we are now assisting other counties in their compliance efforts
- CAR Processing-acting on case w/in 14 days from referral from OCS
 - **Kent-98.2%**, Genesee-77.8, Macomb-99.4, Wayne-46
- Locate-making efforts to locate NCP every 60 days
 - **Kent-88.3%**; Genesee-77.8, Macomb-83.7, Wayne-81.7
- Order establishment-final orders entered in a case
 - **Kent-92.2%**; Genesee-91.4, Macomb 89.4, Wayne 4.3
