#### Rockford East Middle School Test Results Show No PFAS

On Wednesday October 25, 2017 test results from Wolverine and Rose and Westra/GZA were returned to Rockford Middle School. All of the samples from the school showed no detectable level of PFAS. Rockford Public Schools Superintendent Dr. Michael Shibler was able to return the drinking fountains and other water spigots used for food

preparation back to their normal operating positions and suspend the mandated use of bottled water for students and staff.

Test results from Cannonsburg, Crestwood and Lakes elementary schools are still pending.

Shibler issued the following letter to the parents and guardians who have children attending Rockford East Middle.

#### Dear RPS Parents and Staff:

I have received the analytical report from Rose & Westra, the laboratory assigned to test the water quality at East Rockford Middle School. I am happy to report that there were no PFAS detected in the water at ERMS. This is great news!

Beginning Wednesday morning, the water at ERMS will be reinstated and there will be no need to continue the use of bottled water.

As a precautionary measure, we have had samples of water from Cannonsburg, Crestwood, and Lakes elementary schools sent in for testing. The reason being, like ERMS, those three schools also use wells for water. I will notify you as soon as I receive those test results.


#### **New PFAS Mapping Tool**

Using the resources of the Kent County Information Technologies GIS mapping division, the Kent County Health Department (KCHD) launched this new interactive map this week on the KCHD webpage dedicated to the PFAS groundwater contamination issue.

The map, which can be found by clicking here, allows people to enter any address in the top center box and know instantly where that address lies in relationship to the established testing areas. The area in green combines the "Study Area" with the original "Buffer Zone". The area in blue represents the boundaries of the "Southeast Expansion Zone."

Because the map was built and will be maintained using in-house resources, the areas can be quickly modified to reflect any expansion or contraction of the areas.

The map will be updated anytime MDEQ provides additional information.

## **Access Your own Well Records**

Are you looking for specific historical information about your well? You can easily find construction information like the depth of your well, the date it was

installed, casing size and soil formation information as well as a host of other valuable information all for free. By clicking this link <u>www.deq.state.mi.us/well-logs</u> you will be led to the scanned water well record retrieval system. You will find step by step instructions that will provide access to nearly one million wells. You will need Adobe Acrobat to view the information. You can download Adobe Acrobat for free here. While the well water record retrieval system is a great tool, there maybe wells that have not been loaded into the database. You may also complete a Freedom of Information Act Request for well records directly from Kent County here https://www.accesskent.com/Health/PFAS/
