• Prevention Updates

• Intervention Updates – Dr. Jayne Courts

- Intervention subcommittee is moving some 2021 initiatives into 2022
- Enhanced naloxone distribution
 - I Can Narcan support
 - Naloxone vending machine now available at Grand Rapids Red Project

- Messaging Campaign
 - Hoping to formulate PSAs with a destigmatizing and informational/educational focus with videos, social media, newsletters, etc.
- Overdose Fatality Review
 - Hoping to have the first meeting in May 2022, with orientation in April
 - Currently working through administrative tasks (signing DUAs, etc.)
- COSSAP Grant
 - Kent County was successfully selected for the COSSAP grant; more information to come regarding grant initiatives

• Treatment & Recovery Updates – Ross Buitendorp

- Ross Buitendorp, Director of Network Services at Network180, has started as the new co-chair of the Treatment & Recovery subcommittee
- Meeting times for 2022 will be the third Friday of the month from 12-1pm
- Focusing on reducing barriers to physicians prescribing medications for opioid use disorder
- Goal to collaborate with successful local programs to identify what is working and facilitate peer-to-peer targeted education
- Recommendation: think about patient barriers such as transportation to appointments, co-pay ability, etc.

 Center for Integrative Medicine has a walk-in ED bridge clinic that is open to anyone, Mondays-Fridays

• Families Against Narcotics – Chris Becker

- FAN continues to meet the first Tuesday of the month at 7pm at the North Alano Club (1020 College Ave NE), with a virtual option available
- FAN is seeking additional community participation, especially families
- The March 1st forum featured Sgt Joe Abram and Undersheriff Chuck Dewitt presenting on current trends regarding drugs and SUD in Kent County

Leadership A3 – Dr. Ken Fawcett

- Focus on ensuring coordinated efforts within the community to mitigate opioid epidemic, through environmental scan, sharing best practices, and clear communication
- Goal to embed an equity lens within KCOTF strategic plans and ensure proper representation on the KCOTF

• Data Report – Rachel Jantz

- As of the last data download from the Kent County Medical Examiner on March 3, there are 5 pending drug overdose deaths for 2021
- O Data from 2020-2021 show that:
 - 81% of drug overdose deaths include opioids
 - 89% of opioid overdose deaths include fentanyl
 - 68% of all cocaine overdoses include fentanyl
 - The average age of an opioid overdose decedent is 42.2 years
- The last few years have not seen a significant change in the number of opioid overdose deaths in Kent County (2019 – 83; 2020 – 84; 2021 – 82 [provisional])
- Data highlighting fentanyl have been valuable in clinical settings when having conversations with patients who use drugs
