On 8-9-17 at 1020 AM, Kent County Deputies and Sparta Fire/Rescue, responded to a Fatal Traffic Accident on Long Lake Dr. near 14 mile Rd., Sparta Twp. County of Kent. The Fatal Crash involved a single vehicle that had lost control and crashed into a tree. The victim driver was identified as a 16yo female Mya Jane Turoski from Sparta Mi. The victim was the only occupant in the vehicle. The crash remains under investigation.
